1. Organisers

4. Registration and confirmation

Registration to exhibit is made by submitting a completed and signed application form to the Organisers. The Organisers will confirm receipt of Registration in writing by fax and original mail.

5. Terms of payment

A deposit of 50% is required upon registration. Exhibitors should remit the appropriate amount directly to the Organisers. Final balance of 50% is due on **15 January 2014**. All bank charges are to be borne by Exhibitor.

6. Cancellation

If an Exhibitor withdraws his registration, for whatever reason, before he receives either a rejection or confirmation of his registration, any participation fee paid will be forfeited.

If the exhibitor notifies the Organisers of his withdrawal within three months of the start date of the event, he is liable for the total participation fee.

Should the Exhibitor under contract (i.e. in receipt of confirmation) inform the Organisers that he will not participate in the event, providing the Organisers is able to resell the stand without loss, the payment to be made by the exhibitor will be reduced to a handling fee of EUR 800 irrespective of the exhibitor's full liability for additional costs, catalogue fees etc.

7. General terms and conditions of participation

The detailed General Terms & Conditions of Participation are given on the Organiser's website www.africapvsec.com and can be requested in printed form if required.

8. Booth allocation & booth construction

The booth will be allocated in accordance with marketing criteria. No change of booth location is allowed once it has been assigned & informed. The Organisers have the sole and absolute discretion in allotting the area in the

Exhibition Venue for the positioning or construction of booths and determining the location of such booths. All decisions to such effect shall be final and no request for changes will be entertained.

Standard Booths are provided by the Organisers' official contractor and are of a standard design. No variation of the Standard Booth including but not limited to its fascia board, lettering and fittings, shall be allowed unless prior approval is given by the Organisers.

9. 10. Co-exhibiting

The Space or Booth rental to the Exhibitor is personal to the Exhibitor and shall not be transferred, assigned, sub-contracted, sub-let or otherwise howsoever shared with any third party without written confirmation by the Organisers. Any Exhibitor who is found by the Organisers in its absolute opinion to have transferred, assigned, sub-contracted, sub-let or otherwise howsoever shared its Space or Booth with a third party, will be obliged to immediately withdraw from the Exhibition, dismantle its Booth and remove its exhibits at its own expense.

10. Requirements on exhibits & forbiddance on booth transfer.

All the exhibits on display at the show should be consistent with the product range or the brands registered in this application form submitted by the applicants. Those products which have no relevance to the theme of the show are strictly forbidden. The Organisers reserve the right to unconditionally remove their exhibits and can void their exhibitor qualifications. No Exhibitor shall have any claim for any refund in respect of the space licensed, as provided in these General Terms and Conditions or any other monies paid.
